All Fishing Activities must comply with the Liberia Fisheries Regulations 2010 and/or the Laws of the Republic of Liberia. This includes but not limited to:

- No fishing permitted in the inshore Exclusion Zone (IEZ), defined as six (6) nautical miles from the baseline at low tide.
- All vessels are required to have an operating Vessel Monitoring System (VMS)
- All vessels are required to carry a Liberian-appointed observer on board; observers must be provided full cooperation and access
- No person shall use, permit to be used or attempt to use fishing gear that has not been authorized
- No person shall use, permit to be used or attempt to use the method of pair trawling for the purpose of fishing
- No use or carrying of explosives, firearms, lights, electrical devices or poison for the purposes of fishing
- No person shall damage or endanger fishing gear that he or she does not own or use; every effort must be made to avoid conflict with artisanal fishers.
- The operator of each fishing vessel entering or exiting the Fisheries Waters shall declare the type and quantity of fish on board by email or HF Radio to the Bureau of National Fisheries at least twenty-four (24) hours prior to each entry and after each exit
- The operator shall report the vessel's position and total catch by email or HF Radio every twenty-four (24) hours
- A valid and applicable written authorization issued by the Bureau shall be required for:
 - a. Each transshipment;
 - b. Deployment and maintenance of a fish aggregating device;
 - c. Export of catch
- The operator shall maintain fishing and navigational logbooks at all times in the English language
- A fisheries inspector may, for purposes of MCS and/or administration of the Fisheries Regulations without a warrant:
stop, board, enter, search and stay on board any industrial fishing vessel for purposes of exercising his or her powers
- This fishing license must be kept on board the vessel in good condition at all times; the license is not transferable

Any vessel that contravenes any Section of the Fisheries Regulations and/or Laws of the Republic of Liberia shall be subject to penalty in accordance with the Fisheries Regulations and/or the Laws of the Republic of Liberia.

This license is hereby granted to fish in the Exclusive Economic Zone (EEZ) excluding the Inshore Exclusion Zone (IEZ) of the Republic of Liberia.
